1. Admission forms of the Candidates (Male and Female Both) must be accompanied with three (3) copies of fresh Passport size Photographs duly attested (one on face side while other two on the back) by the Head of institute last attended only. Attestation of Admission forms of private Candidates other than gazetted officers of Education Department will not be acceptable.
2. Photographs and other documents may be pasted with GUM, not to be stapled. Otherwise Admission Forms will not be accepted.
3. Incomplete Admission forms will not be entertained under any circumstances.
4. Only those candidates who have passed the HSSC Examination from BISE Malakand can appear for improvement / Additional subjects.
5. Practical fee must be included @ Rs. 50/- per practical subjects (Physics, Chemistry, Biology, Comp: Science, Stat, OLHE, Psychology, HPE and (Lib: Science) Moreover, these subjects cannot be opted by private fresh candidates.
6. Admission forms will be available free of cost in Board office.
